FACTS

WHAT DOES SABAL TRUST COMPANY DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number
- Address
- Account balances
- Name
- Date of birth
- Tax information

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons Sabal Trust Company chooses to share; and whether you can limit this sharing.

What we do

How does Sabal Trust Company protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Sabal Trust Company collect my personal information?

We collect your personal information, for example, when you

- Open an account or become a beneficiary
- Request a transaction or transfer an account
- Are required by law to submit information

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and non-financial companies.

- *Reliance Trust Company*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

- *Sabal Trust Company does not share with nonaffiliates so they can market to you*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Sabal Trust Company does not jointly market*

Other important information

If you receive any email using our name that is requesting your personal information, it was not sent by Sabal Trust Company and could be an attempt at fraud. DO NOT RESPOND. If you receive such an email, please notify a representative at your Sabal Trust Company office immediately.

If you receive a telephone call from someone claiming to be a representative of Sabal Trust Company and the caller is asking for personal information, please ask them to provide their name. Tell the caller you will call them back and contact us at our main number. If they will not provide this information, the call is not from us. Please hang up immediately and contact a representative at Sabal Trust Company.
